Administrative Updates: We have two new staff members beginning in February. On February 10, Brian Robinson, who will be supporting our global career readiness and data initiatives. On February 19, Brittany Cannady will be filling out digital media communications associate position. Both Brian and Brittany are former teachers. We have two more vacant positions – a policy associate and a communications associate that we hope have filled in the coming months.

**<u>Finance Update</u>**: These numbers represent finances through January 31, 2019, which is 59% of the fiscal year. The Center income exceeds the income target due to funds that have been received in this fiscal year, namely the next JPMC grant, but will carry forward into the next. These adjustments are made at fiscal year end.

**Perkins Implementation Strategy:** Advance CTE's Perkins implementation strategy is underway, with many core elements already in place.

### Technical Assistance:

- lowa: In January, Advance CTE and Association for Career and Technical Education (ACTE) staff
  facilitated the state's CTE Advisory Council meeting, including a discussion of draft performance
  targets, strategies to promote work-based learning and use of the state's reserve fund. In addition,
  Advance CTE and ACTE staff are compiling and synthesizing public comments on lowa's Perkins V
  state plan.
- Oregon: In January, Advance CTE and ACTE presented an update on Oregon's Strengthening Career and Technical Education for the 21st Century Act (Perkins V) state plan to a virtual convening of the state's stakeholders.
- Opportunity Gap Analysis Technical Assistance: Advance CTE is providing technical assistance to several states to identify and address access and equity challenges. Advance CTE is in the process of

analyzing CTE enrollment and performance data from Florida to identify access and equity gaps. In February, Advance CTE will work with the New Jersey Council of County Vocational-Technical Schools to pilot the process and deliver a data and root cause analysis workshop. Another pilot is scheduled with two local Perkins consortia in Minnesota in March. After a series of state and local pilots, Advance CTE will finalize a suite of tools—including a data dashboard, root cause facilitation guide and more—which will be made available to members.

### Shared Solutions Workgroups (SSWG)

Work has continued on the deliverables being created through the Middle Grades CTE SSWG. We have our final call with this group in early February and anticipate releasing the resources in March.

As discussed below, the third SSWG on data visualization will be launching shortly.

### **Other Supports**

Our Perkins V Expert Peer Review process has concluded! In total, 37 states and DC participated and receive robust and meaningful feedback on their draft state plans. Staff and ACTE are planning to debrief in February, including discussing how we can measure the impact of the feedback on the final, submitted plans in the spring.

### **State Policy Update:**

**CTE Forward Summit:** Work has begun on Advance CTE's next summit, to be held in fall 2020. We have signed a contract with a facilitation firm to design the event and facilitate on site, as well as secured nine national organizations to serve as co-conveners (ACTE, Council of Chief State School Officers, US Chamber of Commerce Foundation, National Association of State Boards of Education, National Skills Coalition, National Governors Association, National Conference of State Legislatures, National Association of State Workforce Agencies and State Higher Education Executive Officers).

Save the date information will be going out to all State Directors and invited participants soon.

To date, we have secured approximately \$150,000 from The Bill & Melinda Gates Foundation to support the Summit and \$25,000 from Siemens as part of our third round of funding. In January, we submitted a letter of inquiry, the first step in the Joyce Foundation's proposal process, for \$45,000. We have also had positive discussions with JPMorgan Chase. This support – in addition to The Center's reserves if needed – will cover the facilitation firm, all staff costs and meeting expenses for all participants (not including travel).

**Year in Review Report:** In partnership with ACTE and Education Commission of the States, Advance CTE released the <u>State Policies Impacting CTE: 2019 Year in Review</u> report. The report summarizes all CTE and career readiness policies passed in 2019 and identifies key trends based on those policy changes.

**Global Career Readiness Initiative:** Advance CTE is in the initial planning phase of this project supported by the JPMorgan Chase Foundation (JPMC). JPMC will begin publicly announcing funded sites on a rolling basis from mid-February through April; Advance CTE's grant begins on March 1. Advance CTE and Education Strategy Group (ESG) have begun planning a needs assessment process for sites, as well as mapping out key engagement activities with sites throughout the first six months of the project. Advance CTE has begun planning its knowledge management work with sites and is identifying topics for tools, resources and publications in the project's first year.

**ECMC Initiative:** January 1 marked the official beginning of the ECMC initiative, Advancing Postsecondary CTE Data Quality. Advance CTE is in the initial planning stages for the initiative, which includes hiring a policy associate and mapping out the key milestones for the project. A candidate for the policy associate position has been selected and will start in early February.

**IES Blog Series:** The first Q&A in the CTE Research Partnership blog series was <u>posted</u> in January, featuring a conversation between Jill Kroll of the Michigan Department of Education and Dan Kreisman of Georgia State University (and director of the CTEx research collaborative). The piece highlights how CTE researchers can add capacity to state departments in improving and analyzing CTE data.


**Partnership to Advance Youth Apprenticeship (PAYA):** Advance CTE has finalized with New America the core objectives and participants for the PAYA workgroup on youth apprenticeship data. The workgroup is charged with identifying challenges and next steps for improving the collection, validation and use of youth apprenticeship data. The kickoff call for the workgroup will be held in February.

**Data Quality Policy Benchmark Tool:** Advance CTE will convene an expert workgroup of national, state and local leaders to support the development of a policy benchmark tool for CTE data. In February, Advance CTE will begin initial interviews with participants and will begin planning an in-person meeting later in the spring.

**Perkins V Data Visualization Workgroup:** Advance CTE will convene a Shared Solutions Workgroup to discuss challenges and strategies for presenting and reporting Perkins V data, with support from the Bill & Melinda Gates Foundation. The group will be launched in February with support from ACTE.

**Equity Initiative:** Advance CTE held its quarterly call with the Committee on Equity in CTE, which is comprised of representatives from national civil rights, workforce and education organizations. During the call, the Committee discussed how to leverage its collective knowledge and existing resources to help state and local leaders advance equity in CTE.







### View from the Hill

In January, Advance CTE has been following discussions regarding the Fiscal Year 2021 (FY21) Federal budget. President Trump plans to reveal his proposed budget to Congress on February 10 and Advance CTE will be closely following new developments and will evaluate the implications for our members. ### **State Policy Update**

As of January, more than 15 governors have given their State of the State Addresses. When outlining their policy agendas for 2020, many governors celebrated and prioritized CTE. In Arizona, Governor Doug Ducey proposed more funding for CTE trade programs aligned with high-demand careers. In Iowa, Governor Kim Reynolds celebrated expanding high-school registered apprenticeships and proposed \$1 million in funding for work-based learning coordinators.


