## NASDCTEc Business Meeting MINUTES Monday, June 18, 2012 Washington, DC

**Welcome:** Ainsworth welcomed the members to the business meeting.

**Review and Approval of Minutes:** Ainsworth reviewed the minutes from the Fall 2011 meeting. No questions were asked.

**NASDCTEc Financial Report:** Berkenbile shared that NASDCTEc financial position is strong and exceeding income expectations for both states and organizational/associate membership. Fall meeting registrations were slightly lower than projected, however sponsorships are above target, as is interest/dividends. Expenses are in line with income, being at 71% of the budgeted total. **NCTEF Financial Report** Berkenbile shared an overview of NCTEF's financial position. Institute revenue is strong, in particular the sponsorships. Product sales are continuing to trail expectations, although they have picked up since bringing the warehouse to Maryland. Expenses are in line with income, being at 50% of the budgeted total. The majority of the Institute expenses have not been incurred, so the expense portion of the financials will change significantly in the year-end reporting. No questions asked.
