FY13 Funding



Appropriations Process

- February - President submits budget
- April 15 - Budget resolution
- May – August - 12 appropriations bills
- October 1 – New fiscal year begins

President's Budget

- Perkins level funded at \$1.1 billion
- \$1 billion over three years for career academies
- Community College to Career Fund – \$8 billion over 3 years



President's Budget

- Pathways Back to Work Fund - \$12.5 billion
- Workforce Innovation Fund - \$125 million



Congressional Action

- 6 month Continuing Resolution
 - March 27, 2013
 - FY12 levels
- Election impact?
 - Cuts may still happen



Budget Control Act



Budget Control Act

- “Debt ceiling deal”
- \$1.2 trillion cuts over 10 years
- Super Committee failure

Sequestration

- Defense and non-defense programs
- 8.2% across-the-board cuts to NDD in FY13
- No discretion to target cuts in FY13

Sequestration

- Impact on education:
 - Most cuts take effect July 1, 2013
 - Impact Aid cut immediately
 - 2013-2014 school year
 - Pell grants exempt in 2013
- Impact on Perkins in FY13:
 - Approximately \$92 million cut

Spending Caps

- FY14 – 21 = lower approps caps
- Pell grants not exempt
- Congress has discretion to target cuts

Tell CTE's Story

- Focus has been on defense cuts
- Must highlight impact of NDD cuts
- Local media coverage
- School site visits for Congress and media
