State CTE Director Changes

- Puerto Rico has installed a new State CTE Director, Francisco Martinez Oronoz. He has been with the agency for eight weeks, and is now responsible for the island's CTE portfolio.
- Wyoming named Michelle Aldrich as State Director in March. Aldrich comes from the local level, where she taught for many years.
- DC has named Richard Kincaid to fill its vacant State Director position. Richard had served as the interim director since October.
- In March, Maryland's Lynne Gilli notified Advance CTE that she plans to retire in late May or early June after many decades working in the state's CTE office.

Membership Update

Membership Update: In March, Advance CTE received 12 new memberships – one new State Member, one replacement State Member, two Associate-State; six Associate-Nonstate members and one organizational member representing three individuals.

Total membership as of March 31, 2019: 613 individuals

- State Membership*: 56 states (representing 56 State Directors and 197 state members)
- Associate, State: 17
- Associate, Non-state: 132
- Organizational: 47 organizations (representing 211 individuals)

Membership Audit: Staff completed the annual audit of the membership systems (inclusive of our database, email lists and financial records).

Overall, the audit revealed a known weakness with our current system. Our membership database, which also includes our meeting registration forms, allows users to update their information at any time, including their email address. However, we are not notified of changes when they happen. As such, our email lists, which use different platforms, can unknowingly become out of date. Other issues arose due to training gaps among staff, and these issues are being corrected. At the end of each audit, staff also right-size the overall membership numbers to ensure accurate reporting. As such, the numbers displayed above have been reduced by 8, as there were a few individuals being counted who had been cancelled for nonpayment.

2019 Spring Meeting: We've had a phenomenal response to our Spring Meeting registration and sponsorships. We have officially "sold out". We ended registration at 141% of our target, and with 182% of our: sponsorship target.

The meeting's agenda is being developed around the theme of "Be Bold," which is a connection to our Regional Implementation Meetings. Here is a peek into the public agenda, which will be released on Monday, March 4. On April 8, we will focus around creating bold goals for your state CTE system. Tuesday, April 9 will celebrate and highlight bold action and Wednesday, April 10 will explore bold results and debut Advance CTE's latest 50-state report looking at CTE data systems.

Priority: Ensure the adoption and implementation of high-quality state and federal CTE POLICY.

Federal Advocacy Plan:

In March, Advance CTE targeted its advocacy efforts around the Fiscal Year 2020 (FY2020) appropriations process. In addition, Higher Education Act reauthorization discussions are heating up. During March, Advance CTE engaged with over 30 offices on appropriations, the campaign to double the investment in CTE, and/or the reauthorization of the Higher Education Act.

Perkins: As members continue to dig into the provisions in Perkins V and begin four-year state plan development, we will continue to provide on-demand technical assistance to states. In addition, Advance CTE continues to work with partners to present on Perkins V and provide accurate information on the law. The "Perkins V resource roundup" continues to be a successful avenue to communicate about connections between our resources and Perkins V. We released two editions in March: "Perkins V: How can the comprehensive local needs assessment drive improvement?" and "Perkins V: How can states use this opportunity to communicate about CTE?"

Appropriations: Appropriations season kicked into high gear in March with the release of the President's budget request for FY2020 on March 11 (and additional analysis can be found in this blog post). The proposal includes a 12.5 percent cut overall for the U.S. Department of Education and a 9.7 percent cut overall for the U.S. Department of Labor. Investments in the Strengthening Career and Technical Education for the 21st Century Act (Perkins V) were proposed as follows:

• CTE State Grants: proposed level funding for the Perkins Basic State Grants at the amount provided by Congress in FY19. The President's budget also includes the recommendation that Congress authorize changes to increase the fees collected for H-1B visas and redirect 15 percent of that revenue to provide an increase in funding for CTE State Grants. However, we are still examining this proposal and at this point, it is unclear if this would be a practical way to ensure more resources for CTE State Grants and how much funding could be realized.

• National Programs: proposed increase of \$12.58 million above the amount provided by Congress in FY19 to support the new Innovation and Modernization grants authorized under Perkins V.

Advance CTE attended the briefings and hearings related to this proposal and will continue to advocate for Congress to make a strong down payment on the goal of doubling the federal investment made in Perkins in FY2018 by FY2024. Advance CTE and ACTE have partnered on numerous appropriations meetings with staff for key Congressional appropriators and have also made numerous requests to individual offices regarding this request. In addition, the House Dear Colleague letter requesting strong funding for CTE garnered 155 signatures from Representatives of both parties.

In addition, Advance has supported efforts to raise the spending caps put in place by the Budget Control Act to avoid across-the-board cuts to all programs as well as efforts to support other programs that support CTE efforts, such as Title IV-A and Title II of ESSA, and other initiatives that could include provisions favorable to CTE, such as efforts to include investments in CTE in an infrastructure package.

Campaign to Double the Investment in CTE: The campaign to double the federal investment in CTE has 96 supporters as of this writing, representing all 16 Career Clusters ® across 24 states. Advance CTE has started a bi-monthly newsletter and posts blogs regularly to the ISupportCTE.org website. The Spring Meeting will also prominently feature the campaign and Advance CTE will continue to engage members and partners on the campaign.

Workforce Innovation and Opportunity Act (WIOA)

- Advance CTE is continuing to examine the implementation of WIOA across states to determine how WIOA implementation aligns with efforts to advance CTE.
- Advance CTE is continuing to analyze the revised WIOA state plans.
- Resources related to understanding the implications and opportunities for implementation of WIOA continue to be added to the Learning that Works Resource Center.

Higher Education Act (HEA)

- Advance CTE supported four higher education bills that were reintroduced in Congress in March:
 - The Making Education Affordable and Accessible Act, which would expand access to highquality dual-enrollment programs;
 - The Preparing and Retaining Education Professionals Act (PREP Act), which would allow the teacher preparation provisions of HEA to apply to CTE;
 - The Jumpstart Our Businesses by Supporting Students Act (JOBS Act), which would allow Pell Grants to support short-term programs and
 - The College Transparency Act, which would allow for program-level data on postsecondary programs to become available, among other key provisions.
- Advance CTE proposed an update to the organization's HEA reauthorization recommendations to include expanding Pell Grant eligibility to incarcerated individuals, to be voted on by the Board in April.
- Advance CTE is continuing to monitor what the 116th Congress will mean for HEA reauthorization by attending briefings, hearings, webinars, and coalition meetings to gather information and adjust our strategy.

State Policy Update

<u>New Skills for Youth:</u> Staff continue to coordinate with other project team members to manage the work of the grant, which in March included conversations the upcoming NSFY convening, which will take place in May. Additionally, staff reviewed and prepared for the semi-annual state stocktakes for all ten NSFY states.

NSFY Snapshots: The latest round of New Skills for Youth state snapshots was released on March 26. The snapshots feature up to three strategies each state employed in the 2018 calendar year and discuss lessons learned and early evidence of impact from their work. Accompanying the snapshots was an executive summary document describing common themes across the 10 NSFY states. In particular, the executive summary demonstrates early successes the states had in advancing equity and access to high-quality career pathways. Now that the 2018 snapshots have been published, Advance CTE will begin planning the final round, which will cover all of the work completed since the beginning of the initiative.

JPMC Innovation Sites Snapshots: Staff spent March traveling to two additional New Skills for Youth sites – Dallas and New Orleans – learning about the work happening there to improve program quality, access and work-based learning opportunities for learners. Staff also continued interviewing stakeholders at international sites, including South Africa and the UK. In April, staff will interview stakeholders in SE Asia, India and China. Staff have also begun working with a contract to draft snapshots or each of the sites, which will be released this summer.

<u>Joyce Foundation – Postsecondary Program Approval:</u> Advance CTE staff continued to work with leaders in Colorado and Illinois on improving postsecondary program quality. In March, staff turned

their attention to dissemination of the work, and worked with a contractor to develop a one-pager highlighting Advance CTE's postsecondary initiatives. A blog series will also be kicked off in April, starting with a blog post from Colorado's State CTE Director, Sarah Heath, about her work with the Policy Benchmark Tool. Staff also prepared for the April release of the report on credit for prior learning.

Equity Initiative: The equity initiative continues to be a priority for Advance CTE. In March, the partner committee met once again for a webinar, where participants discussed research topics for the new CTE Research Network, headed by AIR, as well as the forthcoming report from the Council of State Governments on CTE and workforce development in state juvenile justice systems. In April, members of the partner committee and member kitchen cabinet will serve as facilitators for a series of breakouts on equity topics at Advance CTE's Spring Meeting. Advance CTE is in the process of developing the fourth equity brief in the <u>Making Good on the Promise</u> series. The fourth equity brief will map out steps state leaders can take to close opportunity gaps in CTE, and will be released this summer.

State of CTE: Data Collection and Use: Advance CTE is preparing a "soft launch" of this year's state of CTE report at the 2019 Advance CTE Spring Meeting with a general session panel and a series of concurrent breakout sessions. The full report will be officially released to the public on April 16. This report will be the starting point for a new initiative on CTE data quality, and Advance CTE staff are designing supplemental tools and resources – including a module for the new state director leadership program, a series of indicator briefs, and a policy benchmark tool – to help State CTE Directors improve CTE data quality and effectiveness in their states.

<u>Policy Benchmark Tool – Dual Enrollment and Articulation:</u> Advance CTE is in the process of developing a new policy benchmark tool. The tool, which is slated to come out in November 2019, will potentially focus on dual/concurrent enrollment, articulation and transfer. Currently, Advance CTE is conducting a literature review on dual/concurrent enrollment, articulation and transfer and interviewing national partners to inform the development of the tool.

Oregon Perkins V Planning: Advance CTE, in partnership with ACTE, kicked off the first phase of work facilitating Oregon's state Perkins V plan process. In March, staff held a virtual kickoff call with state leadership, and designed an interactive 1.5 day session with Oregon state and regional staff, which will take place in mid-April. These activities, along with a stakeholder survey designed by ACTE, and extensive research about the state's CTE system and outcomes, will inform priorities and action planning going forward.


<u>Postsecondary Strategy:</u> Advance CTE staff are progressing through the activities proposed in the organization's postsecondary strategy. Staff continues to work with the Joyce Foundation to create a new resource related to credit for prior learning, to be released in April, and a policy benchmark tool on dual enrollment articulation and transfer.

<u>Knowledge Management Strategy:</u> Advance CTE continues to cultivate a culture of knowledge sharing and management across the team. In addition to facilitating regular staff meeting deep dives, staff have been documenting research, presentations and other information related to their work for access across the team. Additionally, Advance CTE is developing a "CTE Research Warehouse" that includes facts and research across a variety of issues areas. The goal is to make this document available to members later this year to support evidence-based decision making.

<u>Making Career Readiness Count:</u> The third edition of the <u>Making Career Readiness Count report</u> – which analyzes state and federal accountability systems to document how states are measuring career readiness – was released on March 19. The report found that the number of states counting career

readiness in their accountability systems more than doubled since 2014, from 17 to 40. While the previous two versions of the report were written in partnership with Achieve, the third edition was published through the New Skills for Youth initiative in partnership with Achieve, Education Strategy Group and the Council of Chief State School Officers.


Resource Center: The Resource Center sustained a total of 11,330 hits for the month of March. 



Media: We responded to two media requests this month, one from GateHouse Media and another from Education Week. Additionally, Advance CTE was mentioned in an <u>article</u> in the Winchester Start about one of their students speaking on a panel at the upcoming Advance CTE Spring Meeting.

Strategies for Attracting Students to High-Quality CTE (Siemens Grant): All grantees in cohort two (ND, CO, ID) submitted their final reports to be reviewed by staff after the Advance CTE Spring Meeting.

Additionally, staff has continued working with cohort three, which includes five states (AR, GA, IA, SC and UT) to put in place their contracts and begin to implement their proposed work plans. Each grantee will participate in monthly check-in calls and bi-monthly cross-state calls. Staff have been working to put in place a contract with a communications firm to help make the assets created under this grant more visible and easily accessible; the goal is for the work to be completed by summer 2019.

Staff has delivered the Career Advising and Development Training, one of which took place in Arizona in March. The text two will take place in April in Oregon and Utah. The training will be delivered in 12 – 16 states through ASCA and ACTE state-wide chapters, as well as state CTE offices affiliated with the Siemens grant. Components of the training will be delivered virtually through ASCA's online platform beginning in summer 2019.

View from the Hill

In March, the President's Fiscal Year 2020 budget proposal was released, officially kicking off the congressional appropriations process. For Perkins CTE State Grants, the proposal included level funding at the amount provided by Congress in FY19. Additionally, it included a recommendation that Congress authorize changes to increase the fees collected for H-1B visas and redirect 15 percent of that revenue to provide an increase in funding for CTE State Grants. It also proposed to increase National Programs by \$12.58 million above the amount provided by Congress in FY19 to support the new Innovation and Modernization grants authorized under Strengthening Career and Technical Education for the 21st Century Act (Perkins V). Advance CTE has been meeting with staff for congressional appropriators to make the case for investing in CTE State Grants and programs that support CTE-related efforts. Our efforts to share information on Perkins V continued in March with two new editions to our Perkins V newsletter on how can states use this opportunity to communicate about CTE? and how can the comprehensive local needs assessment drive improvement?

We also continued to engage with Congress around the reauthorization of the Higher Education Act (HEA). In March, four bills that we supported were reintroduced: the Making Education Affordable and Accessible Act, which would expand access to high-quality dual-enrollment programs, the Preparing and Retaining Education Professionals Act (PREP Act), which would allow the teacher preparation provisions of HEA to apply to CTE, the Jumpstart Our Businesses by Supporting Students Act (JOBS Act), which would allow Pell Grants to support short-term programs and the College Transparency Act, which would allow for program-level data on postsecondary programs to become available, among other key provisions.



State Policy Overview

On March 7, **Colorado** Governor Jared Polis signed <u>HB1008</u> into law, which amends the Building Excellent Schools Today Act to allow the public school capital construction board to provide grants to support CTE capital construction, which includes construction of public school facilities and equipment for CTE programs.

On March 5, in **Virginia**, <u>SB1434</u> was signed into law. The law directs the Virginia Board of Education to revise its CTE Work-based Learning Guide to expand opportunities for learners to earn credit for graduation through high-quality work-based learning experiences. The law directs the Board of Education to consult business and diverse stakeholders to inform its

revision of the guide.
