**Topic for both calls:** Budget Proposal for FY16

Maryland Skills USA Bus Tour: On Saturday April 18, NCTEF will be co-hosting an event with American Youth Policy Forum and the Maryland Department of Education/Maryland Skills USA to bring about 30 participants representing national education organizations, Congressional offices, press and the philanthropic community to Maryland's State Leadership and Skills Championship. We have invited the Senate CTE Caucus to co-host the event as well.

Participants will have the opportunity to observe employer-designed and judged competitions, talk with current students and recent graduates, and hear from Maryland's state leaders and employers on the value of CTE and experiential learning. Invitations will be going out to participants in the second week of March.

**Roundtable on Competency-based Pathways and CTE:** NASDCTEc is partnering with Achieve to co-host a roundtable on CTE and competency-based pathways on May 7. This will be an invite-only roundtable with representatives from 8-10 states (all members of Achieve's competency-based pathways working group), and focus on elevating common challenges with integrating CTE and competency-based pathways, and potential solutions that can be scaled and replicated within and across states.

Following the roundtable, NASDCTEc is responsible for writing a briefing paper summarizing the event and the overall discussion. This paper will be co-released in June 2015.

**New Partnerships**: NASDCTEc's Executive Director has been appointed to the Pearson Employability Advisory Board, as well as the Certificate Accreditation Program of the American National Standards Institute and the National Academies STEM Workforce Summit Committee (designed to help guide NSF's future investments in workforce programs). NASDCTEc was asked to partner with the Lumina Foundation, CLASP and the Corporation for a Skilled Workforce on an initiative focused on reimaging the credentialing system in the US. The work will include a National Credentialing Summit this fall.

**Finance Committee:** The Executive Committee has appointed Rich Katt to replace Eric Spencer on the Finance/Audit Committee. Eric Spencer resigned from the committee in January 2015. During the Spring Meeting we will be looking to for volunteers to the remaining term of Eric Spencer and two additional terms that expire June 30, 2015. ## CAREER CLUSTERS®

<u>Career Clusters® Leadership Pilot:</u> The Pilots' subcommittees began to dig into their work during the month of February. As the work got underway, some of the subcommittees identified a lead person to work with NASDCTEc to manage the development of potential deliverables.

Specific subcommittee updates are as follows:

- (Joint) Work-based Learning: The subcommittee has chosen to start with the secondary education framework. Anne Freeman of New Jersey has been tapped to lead this work.
- <u>(MN) Course Sequences:</u> This group has already completed work on one deliverable, which will be presented to the broader pilot during the April 10 meeting.
  - The deliverable, a one-page resource that illustrates the development of a program of study, was initially created by Andrew Wermes of Iowa. His initial state-specific work was then adapted for a national context. NASDCTEc has agreed to create a companion resource—an on-demand webinar titled, "Programs of Study 101".
  - The subcommittee, under the direction of Sharon Wendt of Wisconsin, will expand on this work to contextualize it to the Manufacturing Career Cluster. The result will likely be another on-demand webinar/PowerPoint.
  - The subcommittee has also agreed to conduct a case study of the Wisconsin Rigorous Programs of Study grant in manufacturing. NASDCTEc will manage this work.

- (MN) Industry-recognized Credentials: Ginny Karbowski of Minnesota has stepped up to lead the work of this subcommittee, given Minnesota's ongoing initiative to embed industry-recognized credentials (IRCs) into manufacturing programs at the secondary and postsecondary levels. The Minnesota State Team has used the NASDCTEc Manufacturing Credentials List as the basis for its work. In March, the subcommittee will meet to learn more about Minnesota's process and consider how and in what ways it may be used for the subcommittee's work.
- (MN) Employer Engagement: The involved states (Iowa, Wisconsin, Minnesota and Tennessee) have agreed to track their engagement with manufacturing-related employers between March and June. Then the subcommittee will analyze that activity to consider the best ways to promote CCLP and its work to the manufacturing employer community. The subcommittee will work with the pilot's employer representatives to develop talking points and messaging to be used with the employer community.
- (Ag) <u>Labor Market Information/Career Ladders:</u> Due to research and data barriers, this work is currently on hold while other options are investigated.

The pilots will meet jointly from 7-9 a.m. on April 10 at the Omni Shoreham Hotel in Washington, D.C., to provide updates on the deliverables and plan their work for the remainder of the pilot year.

## **2015 Spring Meeting Update:**

- The meeting is in Washington, DC at the Omni Shoreham Wednesday, April 8 10, 2015
- As of March 3, we have 126 registered. Registration is open until March 20, 2015. If you

- Sponsorships have reached an all-time high of \$50,500 with 7 Diamond Sponsors.
- We would like you to be aware of several events that will take place in conjunction with the Spring Meeting, but will not appear on the full agenda. Invitations for these events will be circulated shortly. A list of confirmed events so far:

- The Center for Law and Social Policy (CLASP) will be convening a listening session on postsecondary CTE data issues. Postsecondary members and their staff are encouraged to participate. - Overall we have a very <u>strong agenda</u> that will be featuring a daily theme for each day of the conference:
  - o Wednesday: Cross-sector collaboration and employer engagement
  - o Thursday: Featuring CTE excellence across the country
  - o Friday: Federal policy focus—Perkins, ESEA and Higher Ed
- We are also proud to note that we will have a keynote address from Chauncey Lennon of JP Morgan Chase to start off the meeting on Wednesday, followed by a panel of high-level Administration officials discussing the implementation of the Workforce Innovation and Opportunity Act (WIOA).

**Future of CTE Summit**: We are now confirmed to host the Future of CTE Summit at the Gaylord Palms Resort, outside of Orlando, FL, October 6, 7, and 8, 2015. More details coming soon!

We have made great progress in securing Summit co-conveners. To date, the Council of Chief State School Officers, National Governors Association, National State Boards of Education, Council of State Governments, ACTE, the U.S. Chamber of Commerce and the National Skills Coalition have committed to being co-conveners. We have are working through the process of securing AACC/The National Council of State Directors of Community Colleges as partners, which is looking very positive.

With the event date secured, we will begin to build a full project plan, including the launch of the registration (in March), as well as the pre-event input sessions, briefing papers, webinars, etc. as well as the selection of the planning committee from within our organization and the co-conveners.

**NASDCTEc/Career Clusters** @ **ACTE VISION**: The invitations have gone out to nearly all the sessions NASDCTEc is responsible for at the ACTE VISION event. We will be sharing array of

content soon. But as a preview, the sessions are anchored around the elements of the RPOS framework and include a sequenced set of sessions that showcase how state and local policies, collaboration or initiatives are working in concert to advance high-quality CTE programs of study. NASDCTEc is also participating in the postsecondary planning committee for ACTE VISION. The expectation is that the number of postsecondary-focused sessions will double this year. Lastly, we are working to identify potential sites for tours before the VISION conference.

#### **Publications and Webinars:**

**State Policies Impacting CTE: 2014 Year in Review:** On February 5th, NASDCTEc co-hosted a <u>webinar</u> with ACTE to present findings from our second annual "State Policies Impacting CTE: 2014 Year in Review." The webinar attracted 33 attendees, many of whom were State CTE Directors. And, on February 10th, we hosted a webinar (with more than 40 participants) to do a deeper dive into two states' (Alabama and Kansas) efforts to engage employers, as a follow up to our "The State of Career Technical Education: Employer Engagement in CTE" report.

<u>Employer Engagement: State Perspectives:</u> In February, NASDCTEc hosted a **webinar**, "Employer Engagement: State Perspectives," which built on NASDCTEc's new report on employer engagement in CTE. The webinar featured two states – Kansas and Alabama – and their employer partners to discuss how they work together to improve and align their CTE systems. The webinar can be viewed on-demand here.

**About NASDCTEc and CTE & Student Achievement Fact Sheets:** This month, NASDCTEc released another new **fact sheet**, "CTE & Student Achievement," to explore and clarify the complicated relationship between CTE and student achievement, as well as an updated two-page fact sheet "About NASDCTEc".

<u>CCTC On Demand Webinar:</u> NASDCTEc also released its latest **on-demand webinar** on the Common Career Technical Core's development process, with the PPT slides and talking points available in the members' only section of our <u>website</u>.

**Looking ahead**, we currently do not have a webinar scheduled for March, but plan to host a series of webinars with the Excellence in Action winners in April and May. We also will plan to co-host a webinar with the Asia Society to release a white paper we have co-written (with ACTE and College Board) on global competency and CTE, in either late April or early May. In March, we will be releasing a new policy brief entitled "Endorsements, Electives & More: CTE in State Graduation Requirements," exploring common state approaches to offering or requiring CTE courses and assessments within a statewide set of graduation requirements, offer illustrative examples of state-level policies and elevate implementation issues for consideration.

## **PUBLIC POLICY/LEGISLATIVE:**

## **Legislation/Policy**

## President's Fiscal Year (FY) 2016 Budget Request

- President Obama formally kicked off the budget and appropriations cycle for FY 2016 with his annual budget request to Congress. The request proposes to eliminate the sequester caps mandated by the Budget Control Act of 2011 and increase overall spending on discretionary programs by significant amounts.
- The request calls for an additional \$3.6 billion for the U.S. Department of Education
   (ED) a 5.4 percent increase over FY 2015 funding levels. The budget would also
   increase the U.S. Department of Labor's appropriation by 10.3 percent over last year's
   levels as well.
- The Obama Administration is also proposing \$200 million in additional funding for the creation of the American Technical Training Fund (ATTF), a new competitive grant program similar in size and shape to the soon-to-be expired Trade Adjustment Assistance Community College and Career Training (TAACCCT) grant program.
- Unfortunately no new funding was proposed for the Perkins Act's basic state grant program which is still \$5 million below pre-sequester levels. However, the administration does propose an additional \$2 million for Perkins national activities to administer the ATTF. More coverage on the release can be found <a href="here">here</a>.

#### **ESEA**

- Both Chairman Alexander (R-TN) of the Senate Health, Education, Labor, and Pensions (HELP) Committee and the Chairman of the House Education and the Workforce (HEW) Committee have prioritized the reauthorization of the Elementary and Secondary Education Act (ESEA) in the newly convened 114<sup>th</sup> Congress.
- In the House, the Student Success Act (H.R. 5) was passed by the House Education and Workforce Committee on a strict party line vote that did not garner any Democratic support. Upon its passage from the Committee, the Obama White House issued

- several veto threats and expressed significant concern regarding a number of proposals in the legislation.
- Nonetheless, House Republicans were successful in bringing H.R. 5 to the floor of the
  House where it was considered by the full Chamber. However, conservative groups
  and elements within the Republican Caucus began to lobby against the bill and House
  leadership was forced to remove the bill from the floor for a yet to be determined
  period of time.
- In the Senate, Chairman Alexander and Ranking Member Patty Murray (D-WA) have been negotiating a bipartisan ESEA proposal based on Alexander's recently released discussion draft in January. Negotiations are still ongoing and NASDCTEc expects a bill to be introduced sometime the week of March 9<sup>th</sup>. More coverage of the ESEA process can be found here.
- As ESEA negotiations continue, NASDCTEc was successful in supporting the
  introduction of the Career Ready Act of 2015. Formally introduced by Senators
  Baldwin (D-WI), Kaine (D-VA) and Portman (R-OH), the bill would encourage states to
  incorporate indicators of student career readiness within their accountability systems
  as well as strengthening career counseling components within ESEA's secondary
  school counseling program. NASDCTEc is working with the HELP committee to embed
  these provisions into the larger ESEA negotiation process.

#### **WIOA**

- In January, the U.S. Department of Labor (DOL) quietly announced that they had delayed the release of regulatory guidance for state and local implementation of the recently passed Workforce Innovation and Opportunity Act (WIOA). NASDCTEC expects the U.S. Departments of Labor, Education, and Health & Human Services to release this guidance in late Spring that should provide additional insight into a number of outstanding issues remaining with the law's implementation.
- Since that announcement, DOL has released a Training and Employment Guidance Letter (TEGL) No. 10-34 which lays out the Department's vision for WIOA implementation.

# **Advocacy Plan:**

- NASDCTEc staff continues to meet with key HEW and HELP committee members on the reauthorization of the Perkins Act. Staff has been clear that the reauthorizations of the Elementary and Secondary Education Act (ESEA) and the High Education Act (HEA) will take priority in the new Congress. Perkins reauthorization remains a possibility in the next Congress, but the timing of this process remains unclear at this time.
- NASDCTEc and ACTE have jointly completed comments on the Obama Administration's proposed college ratings framework. (resource attached)
- NASDCTEc submitted formal comments on the recent ESEA discussion draft released by Chairman Alexander. (resource attached)
- NASDCTEc has reengaged with the several coalition groups focused on the Non-Defense Discretionary (NDD) side of the federal budget— the area where the Perkins Act receives its funding. With the Murray-Ryan budget agreement of 2014 expired, statutorily mandated funding caps known as "sequestration" will come back into

effect beginning next year. These caps limit the overall size of federal funding until FY 2021 and will make the fiscal environment extremely tight for the FY 2016 budget and appropriations process and beyond. In order to protect current funding levels and to work towards increases for the Perkins Act, NASDCTEc has continued to work with these coalition groups to advocate for an end to sequestration and for parity between defense and non-defense discretionary spending.

- NASDCTEc has been in discussions with Congressional leadership staff and U.S. Department of Labor and Education leadership regarding ongoing concerns for how WIOA's infrastructure funding provisions will be implemented. Efforts are underway to solicit additional clarification and guidance from the Departments on these issued. We expect additional guidance on this issue at a to-be-determined date this Spring.
