# **CAREER CLUSTERS:**


<u>Career Clusters® Leadership Pilot</u> Since their in-person meeting in April, the Career Cluster Leadership Pilots have continued to make progress on their planned deliverables.

In response to the Spring Meeting's Collaboration Roundtables, the Manufacturing CCLP Subcommittee on Industry-recognized Credentials is mulling ways to update the NASDCTEc Credentials List for Manufacturing.

Below is a synopsis of the planned deliverables and likely timelines, where possible, from both Pilots:

- (Manufacturing) Course Sequences Subcommittee
  - One pager that illustrates the development of a program of study with hyperlinks to relevant national resources -- completed
  - A short on-demand webinar that provides a high-level overview of a program of study – now completed and may be viewed at on the NASDCTEc <u>YouTube</u> page.
  - A case study on the Wisconsin Rigorous Programs of Study grant in manufacturing – interviews completed; case study projected to be published in Summer 2015
- (Manufacturing) Work-based Learning Subcommittee
  - Secondary education framework for Work-based Learning in progress and under review by subcommittee
  - Additional deliverables will be developed based on the foundation provided by this framework – to be determined in Summer 2015
- (Manufacturing) Industry-recognized Credentials Subcommittee
  - Updating the NASDCTEc credentials list timeline to be determined; likely end of Summer 2015
- (Agriculture) Labor Market Information Subcommittee
  - Thanks to recent assistance from Georgetown's Center for Education and the Workforce, the subcommittee is working to cull a list from the American Community Survey to identify a hierarchy of Agriculture careers. – likely end of Summer 2015





<u>Communications Committee:</u> Earlier in the month NASDCTEc conducted a call for members to join the re-launched Communications Committee. The call was sent to all State CTE Directors and Members.

The committee is designed to inform the development of new materials and brainstorm new communications initiatives that benefit membership and raise the profile of their work. This committee will serve as a 'kitchen cabinet,' and advise NASDCTEc, and also serve as a means of engaging members more directly. Members of the committee will tackle the following areas:

- Communication materials (case making resources, communications planning tools, etc.) with a particular focus on how to best position, share and augment CTE: Learning that works for America resources
- Review of current materials (Build your Case and Know the Issues 1-pagers and factsheets) to gauge what is used and what needs to be updated
- Gather ideas for promoting Excellence in Action Award Winners
- Weigh in on the CTE: Learning that works for America user agreement and how to best leverage communication strategies adopted by states
- Provide feedback on materials that come out of the Future of CTE Summit in the fall

Nineteen people from 11 states expressed interested in joining the committee. There will be a call in mid to late-June to introduce NASDCTEc communications initiatives and materials to the committee, as well as discuss next steps over the summer. ## **State Policy**

On May 7, 2015, NASDCTEc partnered with Achieve to co-host a roundtable to discuss how states are integrating CTE into their competency-based pathway systems. Seven states – Connecticut, Illinois, Kentucky, Maine, Michigan, Ohio and Oregon – participated in the conversation, as well as three national partners. The day-long roundtable will be used to inform an upcoming brief on the topic that will be co-authored by NASDCTEc and Achieve.

# **MEETINGS:**

**Future of CTE Summit:** Registration opened on May 11 for *The Future of CTE Summit* to the State CTE Directors (and counterparts) as well as to the staff and members of the eight coconveners. As of May 29, we have 70 state leaders registered from 39 states and Guam, with another two states reserving spots. We will be conducting follow up with the remaining states the first week of June to confirm whether they are or are not participating so we can make those spots available to invited thought leaders. Over the next three weeks, we will finalize the co-convener participants and invited national and state thought leaders.

On May 18, we held the first call of the design team. This team is comprised of NASDCTEc leadership (Kim and Kate); NASDCTEc/NCTEF officers; representatives from the eight coconveners; and other invited though leaders including Kelli Wells of the GE Foundation, Don Henderson of Apple, Dane Linn of the Business Roundtable, Chaney Mosely from Nashville Metro Public Schools, Mark Williams of ADI and the former state CTE director of Illinois, and Marcie Mack of Oklahoma. The initial call was to lay out the expectations for this design team, who is responsible for designing the agenda for the Summit (including all activities, scenarios and groupings of participants), synthesizing the Summit's takeaways, and drafting the final vision. The design team will meet virtually 1-2 times a month through the release of the final vision.

There are a number of activities and resources planned for Summit participants, some of which will be disseminated to the full NASDCTEc members based on their relevance, including:

- A pre-recorded webinar on the 2009 vision summit and final CTE vision document (Reflect, Transform & Lead) (June)
- A "roadmap" to the Summit infographic and handout (June)
- A pre-Summit survey (July)
- A short white paper on lingering challenges and assumptions about CTE (August)
- A pre-Summit webinar (September 17)

## **PUBLIC POLICY/LEGISLATIVE:**

### **Legislation/Policy**

## **FY 2016 Budget and Appropriations**

- The Congressional budget and appropriations process for FY 2016 is in full-swing. Earlier in May, both Chambers approved a budget plan (known as a Budget Resolution) for FY 2016 that maintains the extremely tight spending limits set forth by the Budget Control Act of 2011 (BCA). These limits are known as "sequester caps" which constrain the total amount of money the federal government can spend on all discretionary programs (both defense and non-defense) for the better part of the next decade. Congressional Democrats and the Obama Administration vigorously opposed these moves.
- If Congress were to stick to this budget resolution and pass the 12 necessary appropriations bills individually (which appears to be highly unlikely given disagreement between the White House and Congressional Republicans), education programs, including the Perkins Act's basic state grant program, would receive approximately the same amount of funding as they did in FY 2015. Further out to FY 2017, if Congress were to stick to this budget resolution, the U.S. Department of Education would experience a \$3.5 billion reduction in funding—a move that would likely have a detrimental impact on Perkins funding in that Fiscal Year.
- With the budget framework agreed to by Congress, appropriators have set to work to
  determine how much each cluster of programs— known as 302(b) allocations— will
  receive in FY 2016. The Labor-HHS-Education appropriations bill, where the Perkins
  Act derives its funding, received a \$3 billion reduction by Senate appropriators in late
  May. The House appropriations committee is still working on their 302(b) allocation for
  their version of the Labor-HHS-Education appropriations bill.
- NASDCTEc is expecting Congress to continue work on individual appropriations bills through much of the summer. However, the prospects for "regular order"— where all twelve appropriations bills would be passed separately and signed into law— are extremely slim. We expect another last-minute agreement on appropriations (as has happened the past three years) as the Federal Fiscal Year draws to a close at the end of September 2015.

### **Elementary and Secondary Education Act (ESEA)**

- NASDCTEc expects the full Senate to consider the Every Child Achieves Act (ECAA)— that Chamber's proposal for ESEA reauthorization— to be taken up in late June 2015. NASDCTEc is currently working with a number of Senate offices on CTE-related amendments to be proposed during the Senate debate of ECAA.
- We expect the House ESEA proposal— The Student Success Act (H.R. 5)— to be taken up by the Chamber sometime after the Senate completes its work on ESEA.
- NASDCTEc is expecting a closed-door conference of ESEA sometime later this year, but the prospects for the law's full renewal grow more distant as 2015 marches forward.

# **Workforce Innovation and Opportunity Act**

- On April 16<sup>th</sup>, the U.S. Departments of Labor, Education and Health and Human Services (DOL, ED, and HHS) announced a series of five Notices of Proposed Rulemaking (NPRM) which contain a set of <u>proposed</u> rules for the implementation of the Workforce Innovation and Opportunity Act (WIOA).
- NASDCTEc is concerned with one <u>NPRM jointly developed by DOL and ED</u> which proposes a set of rules governing WIOA's state and local planning options, performance accountability system, and the operation of the One-Stop system.
- NASDCTEc is currently drafting formal comments in response to this proposal via the NPRM's comment period ending on June 16<sup>th</sup> and is working to create draft language for use by State Directors for this same purpose.
- On <u>May 18<sup>th</sup> at 3:00 p.m. ET</u>, NASDCTEc hosted a conference call on these issues to provide further clarification regarding this issue and to discuss next steps with regards to this proposal. Notes from this call have been made available via the State Director Listserv.

## **Advocacy Plan:**

- NASDCTEc staff continue to meet with key HEW and HELP committee members on the reauthorization of the Perkins Act. Staff have been clear that the reauthorizations of the Elementary and Secondary Education Act (ESEA) and the High Education Act (HEA) have taken priority in the 114<sup>th</sup> Congress. Perkins reauthorization remains a possibility, but the timing of this process remains unclear at this time. Further, the possibility for Perkins-related activity remains significantly higher in the House than in the Senate. To that end, we are tentatively expecting a Perkins-related hearing in the House sometime later this year.
- NASDCTEc and ACTE have jointly completed their annual FY 2016 appropriations request to Congress. This request can be viewed <a href="here">here</a>. The request has been supported by several other national organizations and has been used to advocate for a robust investment in the Perkins basic state grant program.
- NASDCTEc completed personalized thank you letters to each of the members of Congress who signed-on in support for FY 2016 Perkins funding. This is part of a broader strategy to position the Association during likely last-minute funding negotiations later this year.
- NASDCTEc has reengaged with the several coalition groups focused on the Non-Defense Discretionary (NDD) side of the federal budget— the area where the Perkins Act receives its funding. With the Murray-Ryan budget agreement of 2014 expired, statutorily mandated funding caps known as "sequestration" will come back into effect beginning next year. As mentioned above, these caps limit the overall size of federal funding until FY 2021 and will make the fiscal environment extremely difficult for the FY 2016 budget and appropriations process and beyond. In order to protect current funding levels and to work towards increases for the Perkins Act, NASDCTEc has continued to work with these coalition groups to advocate for an end to

- sequestration and for parity between defense and non-defense discretionary spending.
- NASDCTEc continues to engage with a loose coalition of employers and education groups around the reauthorization of the Perkins Act. NASDCTEc has been extremely successful in ensuring that its draft legislative language be used as the basis for the coalition's forthcoming proposal for the law's renewal. These negotiations are still underway, but will reflect a broad-based consensus among the groups when finished. These discussions are still ongoing
- In conjunction with ACTE, NASDCTEc continues to draft legislative language aligned to
  its Board-approved Perkins priorities. This draft language is currently undergoing
  revisions to reflect feedback received from Hill staff and other key stakeholder groups.
  Efforts are also underway to draft language on the National Activities section of
  Perkins, although this language is still in the early stages of development.
- NASDCTEc will be dedicating itself over the next two months to ensuring the CTE community's interests are protected as the implementation of WIOA continues through the NPRM process. A State Director's conference call and further supporting materials are planned in the coming weeks and months.
