South Carolina Career Technical Education (CTE) Statistics At-A-Glance: Funding:

- Perkins Funds Received in FY10: \$20,567,894ⁱ
- Perkins Funds Received in FY11: \$18,494,175
- Percent change: -10.08%

CTE Student Outcomes Data:

- ➤ Almost all CTE students (96%) in South Carolina graduated from high school at a higher rate than the statewide rate (74%)¹¹
- ➤ The majority (97%) of secondary CTE students in South Carolina were employed, in the military, or in postsecondary education or advanced training six months after graduation in 2009-2010ⁱⁱⁱ
- Almost all (99%) of secondary CTE students in South Carolina graduated high school on time^{iv}

CTE Enrollment Data:

- ➤ Number of Secondary Students Enrolled in CTE: 211,070°
- Number of Postsecondary Students Enrolled in CTE: 61,319vi

CTE: Preparing South Carolina's Students for Jobs of Today and Jobs of the Future

From today through 2018 in SC:

- → The Marketing, Sales, and Services Career Cluster will be the largest overall.
- → Health Science will be the fastest growing Career Cluster, increasing by 21% by 2018.
- → By 2018, 40% of all jobs in South Carolina will be found in Marketing, Sales, and Services, Hospitality and Tourism, and Business Management and Administration.
- → In SC by 2018, there will be about 225,000 jobs for those with certificates.
