Selection Process

Students are admitted into the Law Enforcement and Public Safety Academy through a highly selective process during their 8th grade. Admission into the Academy is based upon the following criteria:

This correspondence addresses the excellent LEPS (Law Enforcement and Public Safety) program run at Manalapan High School by Ed Wall. The program is designed to introduce, guide, and prepare interested students for career paths in the emergency services. These career paths include firefighting, law enforcement, and the positon of Public Safety Director.

The LEPS program has partnered with the Monmouth County Fire Academy to further enhance the value of the program and provide a realism that a classroom cannot provide. The partnered program includes not only lecture in the multifaceted business of firefighting, but students have also been involved with hands-on firefighting evolutions here at the Academy.

LEPS students receive Academy Certification in Incident Command System Level 100 (I-100), CBRNE (Chemical, Biological, Radiological, Nuclear, Enhanced Conventional Weapons), and Hazardous Materials Awareness (HM-A). Further classes include Fire Behavior, Extinguishers, Search & Rescue, and Hoseline and Fire Stream operations.

The hands-on training here at the Academy reinforce the lectures with training evolutions involving extinguisher selection and use, observation of fire behavior, thermal balance, and use of the thermal imaging camera (TIC) to observe heat patterns in a live fire. Handling of hose lines and rescue work that involves drags and carries of victims are also included.

The LEPS program has provided the Monmouth County fire services with a steady influx of firefighter recruits, serving their communities in both career and volunteer departments. To this end, the Monmouth County Fire Academy has had numerous students from this program attend and graduate the Firefighter 1 course, a rigorous 180-hour course consisting of classroom and hands-on training in firefighting, doing the most noble and virtuous work a human being can be involved in. There is no profession that can be compared with the fire service in terms of mental, emotional, and physical challenge.

We feel the LEPS program sets an outstanding example of Excellence in Action for the students of the Freehold Regional High School District.
